1. **RELEASE AND WAIVER.** I shall indemnify, hold harmless and release the County of Anderson County, Tennessee, its employees, agents and representatives, against any and all damages, claims, demands, actions, causes of action, costs and expenses of whatsoever nature for or because of any matter or thing done, omitted, or suffered to be done by conducting litter pickup. The Volunteer does hereby release and forever discharge and hold harmless Anderson County Government and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, in law or in equity, which arise or may hereafter arise from Adopt-A-Road activities through Anderson County Government. I understand that this Release discharges Anderson County Government from any liability or claim that I as a Volunteer may have against Anderson County Government with respect to bodily injury, illness, or death that may result from Adopt-A-Road activities with Anderson County Government. I also understand that Anderson County Government does not assume any responsibility for or obligation to provide financial assistance or other assistance, including, but not limited to, medical health, or disability insurance or in the event of injury or illness.
2. **MEDICAL TREATMENT.** I shall be responsible and liable for all damage or injury to any persons or property resulting from litter pickup. The Volunteer does hereby release and forever discharge Anderson County Government from any claim whatsoever that arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Adopt-A-Road activities with Anderson County Government.
3. **ASSUMPTION OF THE RISK.** The Volunteer understands that the Adopt-A-Road activities include work that may be hazardous to safety, including, but not

limited to, lifting, climbing steep and/or uneven terrain, removing trash and limbs, and working in unsanitary conditions. I, as an Adopt-A-Road Volunteer, do expressly and specifically assume the risk of injury or harm in the Activities and release Anderson County Government from all liability for injury, illness, death or property damage resulting from the Activities.

4. **OTHER.** The Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Tennessee, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Tennessee. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.

I CERTIFY THAT I HAVE READ THIS DOCUMENT, AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY. I ALSO CERTIFY THAT I HAVE RECEIVED A COPY OF THE SAFETY GUIDANCE AND HAVE COMPLETED THE SAFETY VIDEO TRAINING.
